

**The Pennsylvania Lottery's
Extra Life
Second-Chance Drawing Rules
December 3, 2025
[FINAL]**

1. Second-Chance Drawing: The Pennsylvania Lottery's ("Lottery") Extra Life Second-Chance Drawing ("Drawing") for qualifying instant and terminal-based lottery game tickets:

(a) Qualifying Tickets: Non-winning PA-1762 \$1,000,000 a Year for Life (\$50), PA-1763 \$500,000 a Year for Life (\$20), PA-1764 \$20,000 a Month for Life (\$10), PA-1765 \$10,000 a Month for Life (\$5) and PA-1767 \$500 a Week for Life (\$1) instant lottery game tickets, and winning and non-winning Cash4Life® terminal-based lottery game tickets purchased from a licensed Lottery retailer from December 30, 2025 through February 26, 2026 and imprinted with a web-code ("Qualifying Tickets") are eligible for entry into the Drawing. Terminal-based lottery game tickets purchased via <https://www.pailottery.com> are not eligible for entry in the Drawing.

(b) Participation and entry:

(1) Entrants must have a registered lottery account in order to participate in the Drawing. To create a lottery account, visit <https://www.pailottery.com>. Creating a lottery account is free.

(2) A registered lottery account holder is subject to the iLottery regulations and specifically agrees to be bound by the iLottery terms and conditions located at <https://www.pailottery.com/signup/terms-and-conditions/>, as well as any related policies.

(3) To establish a lottery account, players must provide the following information:

- (i) The player's name as it appears on a valid government-issued identification or tax documents;
- (ii) The player's date of birth;
- (iii) The entire or last four digits of the player's Social Security Number, or comparable equivalent;
- (iv) The player's address;
- (v) The player's telephone number;
- (vi) The player's email address;
- (vii) Any other information established by the Lottery to be necessary to verify the age and identity of the player.

(4) An individual may be required to provide additional information or documentation, as set forth in the iLottery terms and conditions, to establish a lottery account or register for iLottery. The information may be used for iLottery

registration or to confirm information provided by that individual during the registration process.

(5) To enter the Drawing, entrants must submit the identifying information from at least one Qualifying Ticket via the Drawing's promotional web site, available at <https://www.palottery.com>, or the Lottery's official mobile application during the entry period. The identifying information from a Qualifying Ticket may be submitted only once in the Drawing. Entries will automatically be awarded at the time of successful submission of a Qualifying Ticket. No other method of submission will be accepted. Entries submitted using any other method, including entries mailed or hand-delivered to the Lottery, are not valid and will be disqualified.

(6) Each entry must be complete, and the information supplied by the entrant must be accurate. Incomplete entries cannot be accepted.

(7) Only one claimant per entry is allowed.

(8) Entrants must be 18 years of age or older.

(9) Players may submit the identifying information from an unlimited number of Qualifying Tickets in the Drawing.

(10) Once an entry has been submitted it cannot be withdrawn or changed.

2. Drawing description:

(a) The Lottery will conduct one Extra Life Second-Chance Drawing from among all instant and terminal-based lottery game Qualifying Tickets entered into the Drawing. All time references are Eastern Prevailing Time.

(b) The entry period for instant lottery game Qualifying Tickets will begin after 11:59:59 p.m. December 28, 2025, and will end at 11:59:59 p.m. February 26, 2026. The entry period for terminal-based lottery game Qualifying Tickets will begin after 4:59:59 a.m. December 30, 2025, and will end at 11:59:59 p.m. February 26, 2026. All entries received during the entry periods will be entered in the Drawing tentatively scheduled to be held between February 27, 2026, and March 13, 2026.

(c) The entry periods for the Drawing will be posted to the Lottery's publicly accessible web site at <https://www.palottery.com>.

(d) The number of entries an entrant will receive for the Drawing is determined by the purchase price of the Qualifying Ticket entered. The purchase price and corresponding number of entries for instant lottery game Qualifying Tickets is as follows: PA-1762 \$1,000,000 a Year for Life (\$50) = 50 entries; PA-1763 \$500,000 a Year for Life (\$20) = 20 entries;

PA-1764 \$20,000 a Month for Life (\$10) = 10 entries; PA-1765 \$10,000 a Month for Life (\$5) = 5 entries; and PA-1767 \$500 a Week for Life (\$1) = one entry. An entrant will receive 50 entries for each \$1.00 in purchase price for each Cash4Life® Qualifying Ticket submitted into the Drawing. For example, an entrant who submits the web-code from a Cash4Life® Qualifying Ticket with a purchase price of \$2.00 will receive 100 entries into the Drawing.

(e) Players may review prizes won and their entries for the Drawing via the Drawing's promotional web site.

3. Prizes available to be won, determination of winners and odds of winning:

(a) The prize entitlements described below are subject to all restrictions and limitations described in section 4, or those mentioned anywhere else in these rules.

(b) Lottery will conduct one Drawing from among all the entries received during the entry periods as described in section 2(b).

(1) The first entry selected in the Drawing will be a winning entry and the entrant who submitted that winning entry shall be entitled to a prize of \$500,000, less required income tax withholding.

(2) The second and the third entries selected in the Drawing will be winning entries and the entrants who submitted those winning entries shall each be entitled to a prize of \$50,000, less required income tax withholding.

(3) The fourth through the eighth entries selected in the Drawing will be winning entries and the entrants who submitted those winning entries shall each be entitled to a prize of \$10,000, less required income tax withholding.

(4) The 9th through the 58th entries selected in the Drawing will be winning entries and the entrants who submitted those winning entries shall each be entitled to a prize of \$100 iLottery Bonus Money.

(c) All prizes will be paid as a lump-sum cash payment or uploaded to a winning player's lottery account.

(d) Winners of iLottery Bonus Money are not required to claim a prize. Winners of iLottery Bonus Money will have the iLottery Bonus Money credited to their lottery account and will receive an email notifying them that they won a prize.

(e) The number of winning entries to be selected for the Drawing will be posted to the Lottery's publicly accessible web site.

(f) The odds of winning in the Drawing depend upon the number of entries received for the Drawing.

(g) A computer-generated randomizer will be used to select the Drawing winners.

4. Drawing restrictions:

(a) To be eligible to participate in the Drawing, entrants must have complied with the requirements of these rules.

(b) The Lottery is not responsible for late, lost or misdirected entries not entered into the Drawing. The Lottery is not responsible for entries that are not entered into the Drawing because of incompatible internet browsers, mobile Lottery application failure or other technical issues. The Lottery is not responsible for entries not entered due to delays in creating a lottery account or the inability to create a lottery account. If a Drawing entry is selected as a winner and rejected or otherwise disqualified during or following the Drawing, the Lottery will select one entry to replace the rejected or otherwise disqualified entry in accordance with these rules and Lottery procedure. Entries not received for any other reason will not be considered entries.

(c) If any discrepancy exists between these rules and any material describing the Drawing, these rules shall govern.

(d) Employees of the Lottery, 9Rooftops Marketing, LLC, Scientific Games, LLC and MDI Entertainment, LLC and their

subcontractors, or a spouse, child, brother, sister or parent residing as a member of the same household in the principal place of residence of any such person are not eligible to participate in the Drawing. Offer void where prohibited or restricted.

(e) The Lottery reserves the right, in its sole discretion, to cancel or suspend the Drawing and change these rules if the Drawing cannot be conducted as planned due to errors in these rules or advertising, unauthorized intervention, tampering, fraud, technical errors, viruses, worms, bugs or any other cause that, in the Lottery's sole judgment, could corrupt or impair the administration, security, fairness, integrity or proper conduct of the Drawing.

(f) All entries shall be subject to verification by the Lottery.

(g) The Lottery reserves the right, in its sole discretion, to disqualify an entrant found to be tampering with the operation of the Drawing or to be acting in violation of these rules or applicable law.

(h) The Drawing is governed by the laws of the Commonwealth of Pennsylvania. Applicable laws and regulations apply.

(i) Prizes must be claimed within 1 year of the drawing date of the Drawing in which the prize was won. If no claim is made within 1 year of the drawing date of the Drawing in which the prize was won, the right of an entrant to claim the prize won, if any, will expire and the prize money will be paid into the State Lottery Fund and used for purposes provided by statute.

(j) Final determination of winners will be made by the Secretary, whose judgment will be final and binding.

(k) A prize awarded in the Drawing to a person who dies before receiving the prize shall be paid according to 61 Pa. Code § 811.16 (relating to prizes payable after death of a prize winner).

(l) A winner is responsible for all taxes arising from or in connection with any prize won.

(m) A player may only win the prize for which the player is first selected in the Drawing. Subsequent entries, from the same individual, selected in the same Drawing will be disqualified and one replacement entry will be selected.

(n) Winners of iLottery Bonus Money must abide by the iLottery terms & conditions, the iLottery Bonus Policy and these rules. iLottery Bonus Money will expire 90 days from the date on which the winner was notified, via email, of the prize win,

as further detailed in section 3(d)). iLottery Bonus Money has a five-times play through requirement in order to convert the iLottery Bonus Money into cash. For example, for a player winning \$100 of iLottery Bonus Money, the player is required to place \$500 in wagers before the iLottery Bonus Money awarded is converted into cash which may be withdrawn from the player's account.

(o) Prizes are not transferrable.

(p) Other restrictions may apply.
