

**JURASSIC PARK**  
**Instant and Fast Play Lottery Game**  
**Second-Chance Drawing Rules**  
**From the Pennsylvania Lottery**  
**July 22, 2025**  
**[FINAL]**

1. Second-Chance Drawing: The JURASSIC PARK Second-Chance Drawing from the Pennsylvania Lottery for qualifying Fast Play and instant lottery game tickets.

(a) Qualifying Tickets: Non-winning PA-5289 JURASSIC PARK (\$10) Fast Play lottery game tickets and PA-1747 JURASSIC PARK (\$10) instant lottery game tickets ("Qualifying Tickets") are eligible for entry into the Drawing.

(b) Participation and entry:

(1) Entrants must have a registered lottery account in order to participate in the Drawing. To create a lottery account, visit <https://www.PAiLottery.com>. Creating a lottery account is free.

(2) A registered lottery account holder is subject to the iLottery regulations and specifically agrees to be bound by the iLottery terms and conditions located at <https://www.pailottery.com/signup/terms-and-conditions/>, as well as any related policies.

(3) To establish a lottery account, players must provide the following information:

(i) The player's name as it appears on a valid government-issued identification or tax documents;

(ii) The player's date of birth;

(iii) The entire or last four digits of the player's Social Security Number, or comparable equivalent;

(iv) The player's address;

(v) The player's telephone number;

(vi) The player's email address;

(vii) Any other information established by the Lottery to be necessary to verify the age and identity of the player.

(4) An individual may be required to provide additional information or documentation, as set forth in the iLottery terms and conditions, to establish a lottery account or register for iLottery. The information may be used for iLottery registration or to confirm information provided by that individual during the registration process.

(5) To enter the Drawing, entrants must submit the identifying information from at least one Qualifying Ticket via the Drawing's promotional web site, available at <https://www.palottery.com>, or the Lottery's official mobile application during the entry period. The identifying information from a Qualifying Ticket may be submitted only once in the Drawing. Entries will automatically be awarded at the

time of successful submission of a Qualifying Ticket. No other method of submission will be accepted. Entries submitted using any other method, including entries mailed or hand-delivered to the Lottery, are not valid and will be disqualified.

(6) Each entry must be complete and the information supplied by the entrant must be accurate. Incomplete entries cannot be accepted.

(7) Only one claimant per entry is allowed.

(8) Entrants must be 18 years of age or older.

(9) Players may submit the identifying information from an unlimited number of Qualifying Tickets in the Drawing.

(10) Once an entry has been submitted it cannot be withdrawn or changed.

## 2. Drawing description:

(a) The Lottery will conduct one JURASSIC PARK Second-Chance Drawing from among all instant and Fast Play lottery game Qualifying Tickets. All time references are Eastern Prevailing Time.

(b) The entry period for Fast Play lottery game Qualifying Tickets will begin after 4:59:59 a.m. August 5, 2025, and will end at 11:59:59 p.m. November 13, 2025. The entry period for instant lottery game Qualifying Tickets will begin after 11:59:59 p.m. August 10, 2025, and will end at 11:59:59

p.m. November 13, 2025. All entries received during the entry periods will be entered in the Drawing tentatively scheduled to be held between November 14, 2025 and December 2, 2025.

(c) The entry periods for the Drawing will be posted to the Lottery's publicly accessible web site at <https://www.palottery.com>.

(d) The number of entries an entrant will receive for the Drawing is determined by the purchase price of the Qualifying Ticket entered. The purchase price and corresponding number of entries for the Qualifying Ticket is as follows: PA-5289 JURASSIC PARK (\$10) = 10 entries and PA-1747 JURASSIC PARK (\$10) = 10 entries.

(e) Players may review prizes won and their entries for the Drawing via the Drawing's promotional web site.

3. Prizes available to be won, determination of winners, and odds of winning:

(a) The prize entitlements described below are subject to all restrictions and limitations described in section 6, 7, 8, or 9, or those mentioned anywhere else in these rules.

(b) Lottery will conduct one Drawing from among all the entries received during the entry period as described in section 2(b).

(c) The 1st through the 36th entries selected in the Drawing will be winning entries and the entrants who submitted

those winning entries shall each be entitled to a prize of 1 JURASSIC PARK Trip Prize Package, as described in section 4 (relating to JURASSIC PARK Trip Prize Package description) of these rules.

(d) The number of winning entries to be selected for the Drawing will be posted to the Lottery's publicly accessible web site.

(e) The odds of winning in the Drawing depend upon the number of entries received for the Drawing.

(f) A computer-generated randomizer will be used to select the Drawing winners.

#### 4. JURASSIC PARK Trip Prize Package Description:

(a) Each JURASSIC PARK Trip Prize Package ("Trip Prize Package") shall consist of a six-day, five-night trip for the Trip Prize Package Winner ("Prize Winner") and up to one guest to Oahu, Hawaii during or around November of 2026.

(b) The specific date and location of the Trip Prize Package events are subject to change and will be confirmed during the fulfillment process. Each Trip Prize Package shall include:

(1) Round trip airfare, if required, for up to two coach class tickets on a major airline, as defined by the Federal Aviation Administration, from a United States international airport to the Daniel K. Inouye International

Airport in Honolulu, Hawaii (inclusive of all security fees, taxes and surcharges). It is the responsibility of the Prize Winner to comply with the REAL ID Act to the extent that the Act is applicable to the Prize Winner's air travel.

(2) Ground transfers between the Daniel K. Inouye International Airport and the assigned destination hotel and, if necessary, between the hotel and Scientific Games, LLC ("SG") hosted events.

(3) One double occupancy room accommodation (room and room tax only), at a three star or better hotel room in Oahu, Hawaii, for five nights.

(4) Admission to the one tour or excursion selected from a variety of curated tours and activities in and around Oahu for Prize Winner and guest.

(5) \$1,000 spending money for the Prize Winner.

(6) State income tax withholding in the amount of \$140.35 and federal income tax withholding of \$3,431.16 (excluding any additional prizes won during the \$1,000,000 JACKPOT CHALLENGE).

5. \$1,000,000 JACKPOT CHALLENGE Description: The \$1,000,000 JACKPOT CHALLENGE ("CHALLENGE") shall consist of:

(a) Each Prize Winner or Proxy ("Contestant") shall receive the chance to participate in the CHALLENGE.

(b) The CHALLENGE shall afford each Contestant one chance to participate together with Contestants from other participating lotteries for the chance to win cash prizes, as described below.

(c) The CHALLENGE shall consist of:

(1) Admission to the CHALLENGE venue for the Contestant and one guest.

(2) Participation in four ROUNDS of the CHALLENGE, as described below.

(3) ROUND 1: During ROUND 1 each Contestant will be assigned a card from 1 of 2 randomly determined sets of 12 oversized playing cards with a different card front and card back design.

(i) Each Contestant will be presented with a board displaying a set of 12 oversized playing cards with backs facing out.

(ii) The Contestant will choose two of the playing cards to reveal a dollar amount from \$75 to \$1,000 with an AUTO WIN symbol. After the cards are revealed, the Contestant may choose to replace one of the two selected cards with another card.

(iii) The Contestant will win the total dollar amount shown by the two playing cards selected and will advance to ROUND 2.

(iv) If the Contestant selects two playing cards that reveal the same dollar amount the Contestant wins two times the total of the two cards and will advance to ROUND 2.

(v) If either of the playing cards selected by the Contestant contains the AUTO WIN symbol the Contestant will win a total prize of \$1,000 and advance to ROUND 2.

(vi) The total prize won in ROUND 1 ranges from \$75 up to \$1,000.

(4) ROUND 2:

(i) Each Contestant begins ROUND 2 with a ROUND 2 Bankroll of \$100 and will roll two oversized six-sided dice, one at a time.

(ii) One of the two dice displays a 2X multiplier symbol on three sides, a 5X multiplier symbol on two sides and a "VELOCIRAPTOR" symbol on one side. The "VELOCIRAPTOR" symbol divides any prize won by two.

(iii) The second of the two dice displays a 2X multiplier symbol on three sides, a 5X multiplier symbol on two sides and a 10X multiplier symbol on one side.

(iv) After rolling each of the two dice the Contestant will win one of the corresponding prizes as shown below and advance to ROUND 3:

(A) One "VELOCIRAPTOR" and one 2X:

\$100



(B) One "VELOCIRAPTOR" and one 5X:

\$250

(C) Two 2X: \$400

(D) One "VELOCIRAPTOR" and one 10X:

\$500

(E) One 2X and one 5X: \$1,000

(F) One 2X and one 10X: \$2,000

(G) Two 5X: \$2,500

(H) One 5X and one 10X: \$5,000

(v) The total prize won in ROUND 2 ranges from \$100 up to \$5,000.

(5) ROUND 3: During ROUND 3 each Contestant will spin a wheel two times to win a cash prize. The wheel will be divided into 24 segments of equal size as follows:

(i) Two of the segments display a \$5,000 prize amount;

(ii) Two of the segments display a \$2,500 dollar amount;

(iii) Four of the segments display a \$1,000 dollar amount;

(iv) Twelve of the segments display a \$500 dollar amount;

(v) Two of the segments display the words "RAPTOR ATTACK"; and

(vi) Two of the segments display a "JURASSIC PARK" symbol.

(vii) One of the two "JURASSIC PARK" segments also displays a gold star and the word "START" to indicate the required starting position of the wheel prior to each spin in ROUND 3 (the "START Segment").

(viii) SPIN #1: Subject to the eligible spin requirements to be defined in the final official event details (the "CHALLENGE Details"), each Contestant will spin the wheel.

(A) If the wheel stops on a dollar amount segment, the Contestant wins that amount and proceeds to SPIN #2.

(B) If the wheel stops on a "JURASSIC PARK" segment, the Contestant wins a prize of \$5,000 and proceeds to SPIN #2.

(C) If the wheel stops on a "RAPTOR ATTACK" segment, the Contestant wins nothing and proceeds to SPIN #2.

(D) If the Contestant's spins are ineligible two times, as defined in the CHALLENGE Details, the Contestant wins a prize of \$500 and proceeds to SPIN #2.

(ix) SPIN #2: Subject to the eligible spin requirements to be defined in the CHALLENGE Details, each Contestant will spin the wheel.

(A) If the wheel stops on a dollar amount segment in SPIN #1 and a dollar amount segment in SPIN #2 the Contestant wins the sum of those dollar amounts and advances to ROUND 4.

(B) If the wheel stops on a dollar amount segment in SPIN #1 and a JURASSIC PARK segment in SPIN #2, the Contestant wins the dollar amount in SPIN #1, plus \$5,000 and proceeds to ROUND 4.

(C) If the wheel stops on a dollar amount segment in SPIN #1 and a "RAPTOR ATTACK" segment in SPIN #2, the Contestant wins the dollar amount in SPIN #1 and advances to ROUND 4.

(D) If the wheel stops on a dollar amount segment in SPIN #1 and the Contestant's spins are ineligible two times in SPIN #2, as defined in the CHALLENGE Details, the Contestant wins the dollar amount in SPIN #1, plus \$500 in SPIN #2 and advances to ROUND 4.

(E) If the wheel stops on a "JURASSIC PARK" segment in SPIN #1 and a dollar amount segment in SPIN #2, the Contestant wins \$5,000 for the "JURASSIC PARK" segment in

SPIN #1, plus the dollar amount in SPIN #2 and advances to ROUND 4.

(F) If the wheel stops on a "JURASSIC PARK" segment in SPIN #1 and a "RAPTOR ATTACK" segment in SPIN #2, the Contestant wins \$5,000 for the "JURASSIC PARK" segment in SPIN #1 and advances to ROUND 4.

(G) If the wheel stops on a "JURASSIC PARK" segment in SPIN #1 and a "JURASSIC PARK" segment in SPIN #2, the Contestant wins \$50,000 and advances to ROUND 4.

(H) If the wheel stops on a "JURASSIC PARK" segment in SPIN #1 and the Contestant's spins are ineligible two times in SPIN #2, as defined in the CHALLENGE Details, the Contestant wins \$5,000 for the "JURASSIC PARK" segment in SPIN #1, plus \$500 in SPIN #2 and advances to ROUND 4.

(I) If the wheel stops on a "RAPTOR ATTACK" segment in SPIN #1 and a dollar amount segment in SPIN #2, the Contestant wins the SPIN #2 amount, and advances to ROUND 4.

(J) If the wheel stops on a "RAPTOR ATTACK" segment in SPIN #1 and a "JURASSIC PARK" segment in SPIN #2, the Contestant wins a prize of \$5,000 for the "JURASSIC PARK" segment in SPIN #2 and advances to ROUND 4.

(K) If the wheel stops on a "RAPTOR ATTACK" segment in SPIN #1 and a "RAPTOR ATTACK" segment in SPIN #2, the Contestant wins \$10,000 and advances to ROUND 4.

(L) If the wheel stops on a "RAPTOR ATTACK" segment in SPIN #1 and the Contestant's spins are ineligible two times in SPIN #2, as defined in the CHALLENGE Details, the Contestant wins \$500 and advances to ROUND 4.

(M) If the Contestant's spins are ineligible two times in SPIN #1 and in SPIN #2, as defined in the CHALLENGE Details, the Contestant wins \$500 in SPIN #1, plus \$500 in SPIN #2 and advances to ROUND 4.

(x) The total prize won in ROUND 3 ranges from \$500 up to \$50,000.

(6) ROUND 4: During ROUND 4 each Contestant will press a button ("Button") to illuminate a space on a digital prize board ("Prize Board") displaying 18 squares, each containing a prize symbol, which continuously move around the Prize Board. Each Contestant will press the Button to randomly land on one of the prize symbols. Each Contestant will be given the chance to press the Button up to three times to win a cash prize of up to \$1,000,000. After pressing the Button, the lighted marked will stop on a square containing a prize symbol and the Contestant will win the corresponding prize as shown below:

(i) The Prize Board squares will each display one of the following prize symbols and corresponding values:

(A) "DINO TRACKS" prize symbol: \$1,000

(B) "JUNGLE" prize symbol: \$1,500

(C) "SHAVING CREAM" prize symbol:

\$2,000

(D) "PARK VEHICLE" prize symbol:

\$2,500

(E) "DNA STRAND" prize symbol: \$3,000

(F) "JURASSIC PARK" logo prize symbol:

\$5,000

(G) A "VELOCIRAPTOR" symbol, which

will divide the total prize won in STAGE #2 or STAGE #3 by two.

(ii) STAGE #1: The "VELICORAPTOR" prize symbol will not appear on the STAGE #1 Prize Board. The Contestant will press the Button and the lighted marker will randomly land on one of the prize symbols. The Contestant will win the corresponding prize amount revealed on the selected prize symbol as shown above. After completing the STAGE #1 Prize Board, the Contestant may proceed to STAGE #2 with their STAGE #1 prize amount won ("ROUND 4 Bankroll") or end the CHALLENGE.

(iii) STAGE #2: Three "VELOCIRAPTOR" prize symbols will replace three of the STAGE #1 prize symbols in STAGE #2. The Contestant will press the Button and the lighted marker will randomly land on one of the prize symbols. The corresponding prize amount revealed on the selected prize symbol as shown above will be added to the Contestant's ROUND 4 Bankroll. If the lighted marker lands on a "VELOCIRAPTOR" prize symbol the Contestant will divide the ROUND 4 Bankroll by two and win that amount. After completing the STAGE #2 Prize Board, the total prize amount won by the Contestant in STAGE #2 will be added to the ROUND 4 Bankroll and the Contestant may proceed to the STAGE #3 Prize Board with their ROUND 4 Bankroll or end the CHALLENGE.

(iv) STAGE #3: An additional three "VELOCIRAPTOR" prize symbols will replace an additional three of the STAGE #2 Prize Board winning symbols in STAGE #3. The Contestant will press the Button and the lighted marker will randomly land on one of the prize symbols. The Contestant will win the corresponding prize amount revealed on the selected prize symbol and as shown above and the CHALLENGE will end. If the lighted marker lands on a "VELOCIRAPTOR" prize symbol the Contestant will divide the current ROUND 4 Bankroll by two and win that amount. The Contestant's STAGE #3 prize amount will be added to the Contestant's ROUND 4 Bankroll and the CHALLENGE

ends. In the event that a Contestant wins a prize of \$1,000 in STAGE #1 and lands on a "VELOCIRAPTOR" symbol in STAGE #2 and a "VELOCIRAPTOR" symbol in STAGE #3 the player will win a minimum prize of \$325.

(v) ROUND 4 BONUS CASH PRIZE: If the Contestant lands on the same prize symbol in all three STAGES the Contestant will win a BONUS CASH PRIZE. If three "DINO TRACKS" symbols appear the Contestant will win a prize of \$3,000 and a BONUS CASH PRIZE of \$17,000 for a total prize of \$20,000. If three "JUNGLE" symbols appear the Contestant will win a prize of \$4,500 with a BONUS CASH PRIZE of \$35,500 for a total prize of \$40,000. If three "SHAVING CREAM" symbols appear the Contestant will win a prize of \$6,000 and a BONUS CASH PRIZE of \$54,000 for a total prize of \$60,000. If three "PARK VEHICLE" symbols appear the Contestant will win a prize of \$7,500 and a BONUS CASH PRIZE of \$72,500 for a total prize of \$80,000. If three "DNA STRAND" symbols appear the Contestant will win a prize of \$9,000 and a BONUS CASH PRIZE of \$91,000 for a total prize of \$100,000. If three "JURASSIC PARK" symbols appear the Contestant will win a prize of \$15,000 and a BONUS CASH PRIZE of \$985,000 for a total prize of \$1,000,000.

(vi) The total prize won in ROUND 4 and the ROUND 4 BONUS PRIZE ranges from \$325 up to \$1,000,000.

6. Prize Package restrictions:



(a) There is no cash option for the Trip Prize Package.

(b) The Lottery is not responsible for injury, loss or damage to person or property in connection with the Trip Prize Package. A Prize Winner and guest participate solely at their own risk and responsibility.

(c) Lottery is not responsible for Trip Prize Package fulfillment. Lottery disclaims any responsibility for any and every occurrence with respect to fulfillment or enjoyment of the Trip Prize Package.

(d) All Prize Winners must be 18 years of age or older at the time of the scheduled Trip Prize Package in order to participate in the CHALLENGE. If the Prize Winner is not 18 years of age or older at the time of the scheduled Trip Prize Package, they may designate a Proxy to participate in the CHALLENGE. The designated Proxy must be 18 years of age or older at the time of the scheduled Trip Prize Package. If the Prize Winner's guest is a minor, the Prize Winner must either be the parent or legal guardian of such guest, or must present a notarized, written consent from the minor's parent or legal guardian for the minor guest to accompany the Prize Winner on the Trip Prize. Prize Winners are solely responsible for the actions of accompanying guests.

(e) By accepting the Trip Prize Package, Prize Winner and guest agree to a background investigation, derived from public information, prior to the scheduled Trip Prize departure date.

(f) By accepting the Trip Prize Package, Prize Winner and guest agree to follow all health and safety protocols, including always wearing a facemask and following social distancing guidelines, as instructed by the event's staff and volunteers and all federal, state, and local guidelines relating to COVID-19 or any pandemic.

(g) All expenses involved with or related to the Trip Prize Package not specifically included in the JURASSIC PARK Trip Prize Package Description, as described in section 4, above, including, without limitation, ground transportation, transfers, additional hotel amenities (i.e., spa services, internet access, phone calls, laundry services, room service, fees and gratuities), airline change fees, airline premium seat fees, airline baggage fees both checked and carry on, travel insurance and personal expenses such as laundry, valet service, photos, souvenirs, and other incidentals), are the responsibility of Prize Winner and guest.

(h) Prize Winners will be required to submit a valid major credit card to the hotel to cover all expenses not specifically awarded as part of the Trip Prize Package.

(i) Travel and hotel accommodations are subject to availability.

(j) The date, location and activities for any events included within the Trip Prize Package may be subject to change. The Lottery is not responsible if any event is delayed, postponed, or cancelled for any reason, in whole or in part, and in such event, the Lottery's only obligation is to award the other elements of the Trip Prize Package. No compensation will be paid in lieu of any cancelled event or any other element of the Trip Prize Package.

(k) Prize Winners and guests must comply with all of the rules and regulations of the venues where the events are held and all applicable federal, state, and local government and/or agency laws, rules, orders, and regulations as well as any rules, regulations, and safety guidelines. Prize Winners acknowledge that if winners or guests behave in a disorderly or disruptive manner or with intent to annoy, abuse, threaten, or harass any other person at any event, winners and/or guests may be removed from the venue, be denied entry, or have any prizes won during the Trip Prize revoked, as determined by SG or its designee(s) in their sole and absolute discretion.

(l) Prize Winners who do not elect to take a guest, or whose guest, for any reason, does not actually take the trip,

are still subject to the full amount of any taxes due on the total value of the Trip Prize Package.

(m) By accepting any ticketed portion of the Trip Prize Package, Prize Winners agree to abide by any terms, conditions, and restrictions provided. Lost, mutilated, or stolen tickets, vouchers, certificates, or pre-paid gift cards will not be replaced.

(n) Guests of Prize Winners may elect to sit with Prize Winners during the CHALLENGE but may not participate unless designated as the Prize Winner's Proxy.

(o) If a Prize Winner chooses not to travel or becomes ineligible for any reason, provided travel has not yet been booked, that winner may appoint a Proxy during the fulfillment process and the Prize Winner shall receive any prize won by the Proxy.

(p) If, after claiming the Trip Prize, the Prize Winner is traveling via air and fails to appear at the designated time and place of departure (excluding flight delays), SG will use reasonable efforts to reschedule the flight at the expense of the Prize Winner. If SG is not able to reschedule the flight, then the Prize Winner will not participate in the trip portion of the Trip Prize (i.e., air travel, lodging and ground transfers) with the exception of the one thousand dollars (\$1,000) cash portion of the Trip Prize,

less any tax withholdings; however, the Lottery or SG will appoint a Proxy to participate in the CHALLENGE for the Prize Winner, and the Prize Winner shall receive any prizes won by the Proxy (less applicable tax withholdings and debt set-off). SG assigned proxies are selected from a pool of off-duty EMS workers, firefighters and police personnel hired for the CHALLENGE.

(q) If, after claiming the Trip Prize Package, the Prize Winner fails to check in to the participating hotel when arriving in Honolulu, Hawaii, SG will use reasonable efforts to hold the participating hotel reservation. It is the Prize Winner's responsibility to communicate with SG in the event of a delay in hotel registration and/or required CHALLENGE registration. If Prize Winner has communicated any delay to SG, SG and the participating hotel will hold the hotel room on behalf of the Prize Winner.

(r) If the Prize Winner fails to check in to the participating hotel when arriving in Oahu, Hawaii and does not either communicate any delays to SG or register with SG for the required CHALLENGE registration check in with SG, and SG cannot contact the Prize Winner, the participating hotel room reservation will be cancelled and the balance of the trip portion of the Trip Prize Package shall be forfeited, including but not limited to participating hotel room, airport ground

transportation, CHALLENGE participation and any and all other non-contracted portions of the prize provided to the winner on SG's behalf, with the exception of the \$1,000 spending money and return airfare, less any required tax withholdings. In the event that a Prize Winner's participation is forfeited, a Proxy will be appointed and the Prize Winner will receive any prize won by the Proxy.

(s) If, after claiming the Trip Prize Package, the Prize Winner fails to arrive for scheduled CHALLENGE participation, the Prize Winner will forfeit the right to personally participate in the CHALLENGE and a Proxy will be appointed. The Prize Winner will receive any prize won by the Proxy.

(t) In the event that a Prize Winner is determined to be unable to attend the trip after the Trip Prize has been booked, the balance of the Trip Prize shall be forfeited with the exception of the \$1,000 spending money portion of the Trip Prize, less any tax withholdings; however, the Lottery or SG will appoint a proxy to participate in the CHALLENGE for the Prize Winner. The Prize Winner shall receive any prizes won by the Proxy (less applicable tax withholdings and debt set-off).

(u) In the event that the Prize Winner does not designate a Proxy and a Proxy becomes necessary to participate in the CHALLENGE, for any reason, SG or the Lottery will appoint

a Proxy. The Prize Winner acknowledges that the appointed Proxy will have to make decisions on behalf of the Prize Winner and therefore that the Prize Winner delegates the power, authority, or discretion to the appointed Proxy to make such decisions on the Prize Winner's behalf. There shall be no charge for the appointment of a Proxy. The Prize Winner will receive any prize won by the Proxy.

(v) Except as set forth above, no prize element substitution, cash substitution, assignment, or transfer of the Trip Prize Package or any elements thereof is permitted. Any unused elements of the Trip Prize Package will be forfeited, will not be redeemable for cash, and may not reduce the prize value awarded for tax purposes.

(w) The total amount of any cash prize won, less required income tax withholding, will be mailed to each Prize Winner within 30 business days after the Prize Winner's departure from Hawaii. SG shall withhold from such cash prizes the minimum required federal tax withholdings and any applicable state tax withholdings and shall deposit said withholdings on behalf of the Prize Winner to the appropriate agencies. The Prize Winner will receive an IRS Tax Form W-2G, and may be responsible for additional state or federal taxes.

(x) In the event that a Trip Prize Package is not claimed or is refused by the Prize Winner, the Lottery will

select an alternate winner according to Lottery procedure, provided that such prize is still available and time requirements have not elapsed.

(y) All prizes won by the Contestant will be subject to the Lottery winnings intercept under 23 Pa.C.S.A. § 4308 or 72 P.S. § 215.

(z) The final details of the Trip Prize Package will be mailed to the Prize Winner prior to the scheduled departure date.

7. Prize claim procedures:

(a) Winners of any prize awarded in the Drawing will be contacted by email by the Lottery to initiate the prize claim procedure.

(b) Winners will have 14 calendar days from the date they are notified by the Lottery, pursuant to this section, to claim their prizes. In order to claim their prizes, winners must respond to the Lottery's email regarding prize claim procedure and must submit a properly completed prize claim form within 14 calendar days from the date they are notified by the Pennsylvania Lottery. Failure to comply with the prize claim requirements as set forth herein, for any reason, shall result in the winner forfeiting their right to receive the prize. Another alternate winner will be awarded the respective prize, according to Lottery procedure.



(c) By entering into the Drawing, players agree to be bound by these rules and the prize claim requirements set forth herein, and expressly waive any claim against the Lottery for a prize not awarded in conformance with these rules.

8. Delinquent Support Offset:

(a) If the Department of Human Services, pursuant to 23 Pa.C.S.A. § 4308, the Department of Revenue or the Administrative Office of Pennsylvania Courts, pursuant to 72 P.S. § 215, determines that a prize winner is a delinquent support obligor as provided in 23 Pa.C.S.A. § 4308 or 72 P.S. § 215, and if the amount of any arrearages shall be \$1,000 or less, the amount of any arrearages shall be deducted from the spending money portion of the Trip Prize Package. After the delinquent support obligation is met, the Prize Package winner will receive the remaining portion of the Prize Package spending money, if any, which shall be fulfilled according to Lottery procedure.

(b) If the Department of Human Services, pursuant to 23 Pa.C.S.A. § 4308, the Department of Revenue or the Administrative Office of Pennsylvania Courts, pursuant to 72 P.S. § 215, determines that a prize winner is a delinquent support obligor, as provided in 23 Pa.C.S.A. § 4308 or 72 P.S. § 215, and if the amount of any arrearages shall be greater than \$1,000, the prize winner shall forfeit the prize and shall be

considered to have waived their right to receive the prize. In this event, the Lottery will select another entry to replace the forfeited entry in accordance with these rules and Lottery procedure.

9. Drawing restrictions:

(a) To be eligible to participate in the Drawing, entrants must have complied with the requirements of these rules.

(b) The Lottery is not responsible for late, lost or misdirected entries not entered into the Drawing. The Lottery is not responsible for entries that are not entered into the Drawing because of incompatible internet browsers, mobile Lottery application failure or other technical issues. If an entry is selected as a winner and rejected or otherwise disqualified during or following the Drawing, the Lottery will select another entry to replace the rejected or otherwise disqualified entry in accordance with these rules and Lottery procedure.

(c) If any discrepancy exists between these rules and any material describing the Drawing, these rules shall govern.

(d) Employees of the Lottery, 9Rooftops Marketing, LLC, Scientific Games, LLC and MDI Entertainment, LLC, and their subcontractors, or a spouse, child, brother, sister or parent residing as a member of the same household in the principal

place of residence of any such person are not eligible to participate in the Drawing. Offer void where prohibited or restricted.

(e) Universal Studios Licensing LLC ("Universal") and Amblin Entertainment, Inc. ("Amblin"), each of their parents and/or any of their subsidiaries, affiliates or licensors (Universal, Amblin and each of their parents, subsidiaries, affiliates, and licensors are collectively referred to hereinafter as, the "Universal Entities") and are not sponsors or administrators of the Drawing or CHALLENGE.

(f) The Lottery reserves the right, in its sole discretion, to cancel or suspend the Drawing and change these rules if the Drawing cannot be conducted as planned due to errors in these rules or advertising, unauthorized intervention, tampering, fraud, technical errors, viruses, worms, bugs, or any other cause that, in the Lottery's sole judgment, could corrupt or impair the administration, security, fairness, integrity, or proper conduct of the Drawing.

(g) All entries shall be subject to verification by the Lottery.

(h) The Lottery reserves the right, in its sole discretion, to disqualify an entrant found to be tampering with the operation of the Drawing or to be acting in violation of these rules or applicable law.

(i) The Drawing is governed by the laws of the Commonwealth of Pennsylvania. Applicable laws and regulations apply.

(j) A prize awarded in the Drawing to a person who dies before receiving the prize shall be paid according to 61 Pa. Code § 811.16 (relating to prizes payable after death of a prize winner).

(k) A winner is responsible for all taxes arising from or in connection with any prize won.

(l) A player may only win the prize for which the player is first selected in the Drawing. Subsequent entries, from the same individual, selected in the Drawing will be disqualified and another replacement entry will be selected.

(m) Prizes are not transferrable.

(n) Other restrictions may apply.
